Town Meeting Allocation of Funds:

The Trust was made aware that town meeting has approved \$20,000.00 as requested by the Affordable Housing Trust.

Housing Production Plan:

Chairperson Sherry would like the housing plan goals which were noted in the approved Plan to be on the agenda for action and implementation.

The five goals were noted:

- Maintain Medway's Affordable stock at over the state's 10 percent Affordable Housing Goal
- Address local housing needs with a greater mix of housing types, particularly small apartments, accessible housing, and stater homes.
- Distribute new housing options in strategic locations and through reuse opportunities to meet local housing need and to comply with the State's housing choice legislation.
- Support residents in need to help them afford to remain in Medway.
- Increase Medway's capacity to implement housing initiatives through enhanced local and regional coordination.

Invoices:

The Trust was presented with a bill from KP Law.

On a motion made by Jack Wolfe, seconded by Glen Trindade, the Trust approved paying the bill for KP Law in the amount of \$580.50.
