Meeting for November 26th was called to order at 6:31pm by Mr. Heavey. **Called to Order:** Minutes from August 26th, September 16th, and September 30th were reviewed **Minutes Review:**

and unanimously approved by the Board.

Agenda Item 1:

Irrigation Well Permits (3) Medway Realty, LLC 106 Main Street

Ms. Hallal presented to the Board that 3 irrigation permit applications; noting permit locations on the property satisfy our regulations. Ms. Hallal explained that they want to cosmetically improve the strip mall; displaying the plot plan. She noted that they applied for 3 wells, but all may not be needed. Mr. Heavy posed the question about areas for recharge/drainage on-site. It was explained by Mr. Hailer that the intent is put in a whole new system; catch-basins will be replaced, storm septors, and irrigation intend to be installed/upgraded.

The Board unanimously approved the 3 irrigation well permits for 106 Main Street.

Agenda Item 2:

Well Permit Greg Whalen 78A Fisher Street Mr. Whalen presents to the Board for a second time, revisions from a new engineer. Ms. Hallal showed the Board the proposed site of where the house well would be and where the present well is currently standing. She also explained that they had previously put in a well without a permit, so whatever the engineer decides to do with the unpermitted well, she will be notified. She requested that the Board sign the site plan and the well permit.

The Board unanimously approved the well permit for 78A Fisher Street.

Agenda Item 3:

Septic Repair Permit Barbara Kewriga 25 Oakland Street

Ms. Hallal showed the plot plan of 25 Oakland Street to the Board, stating they have satisfied the request of everything required for the permit. Mr. Heavey requested that the engineer make note of what surrounds the property on future plot plans, and Ms. Hallal said she would address it with the engineer. Mr. Heavey questioned Ms. Hallal if there were variances and if water table was in good standing. Ms. Hallal stated that these questions have been pre-confirmed with Conservation and that there are no variances and

the water table is currently in good standing.

The Board unanimously approved the septic repair permit for 25 Oakland Street.

other vaping instruments.
