## BOARD OF HEALTH MINUTES

**Call to Order:** 5:33pm

**Minutes Review:** March 7<sup>th</sup> minutes unanimously approved after verification that OML Complaint was sent to complainant.

### Agenda Item 1:

Review of Minutes from  
October 4<sup>th</sup>, 2021.

Mr. Lindstrom started by asking the the Board if they had a chance to review the minutes from October of 2021. Misunderstanding of instructions by the Board reviewing the entire document of minutes, but was halted once instructed by Ms. OBrien that an email was previously sent to the Board stating that there were only 3 things that had not been rereviewed; 13 Stable Way (9 chickens), 3 Copper Drive (new septic system), and 153 Lovering Street (6 chickens.); therefore not the agenda in it's entirety needed to be reviewed. Once information was clarified, the Board continued to vote on the 3 agenda items that had not been re-reviewed and posted.

*Mr. Lindstrom made the motion to approve the three items as listed on the agenda. Mr. Mill seconded the motion. All approved.*

**13 Stable Way, 9 chickens:** *Mr. Abdi made the motion to approve after verifying it was a 1 family residence, seconded by Mr. Mill, approved by all.*

**3 Copper Drive, new septic system:** *Ms. Harris made the motion to approve, Mr. Mill seconded motion, approved by all.*

**153 Lovering Street, 6 chickens:** *Mr. Hill made the motion to approve, seconded by Ms. Tonelli, approved by all.*

### Agenda Item 2:

CN Construction Group  
(Disposal Works Installers  
Permit)

Ms. Hallal stated to the Board that she had reviewed all documents pertaining to this Disposal Works Installers permit and confirmed that everything was in order, recommending to the Board that they approve his permit application. Mr. Lindstrom posed the question what a Disposal Works Installers License entails, and Ms. Hallal explained that it is another name for septic system installer.

*Mr. Mill made the motion to approve, seconded by Ms. Tonelli, approved by all.*

**Agenda Item 3:**  
DJ & Associates  
(Disposal Works Installers  
Permit)

Ms. Hallal explained that she had done extensive research on this applicant; having all information required under our regulations, and made a recommendation to approve.

*Ms. Tonelli made the motion to approve, seconded by Mr. Abdi, all approved.*

**Other:**

Ms. Harris brought up the subject of Town Meeting, and whether or not it should be presented to the citizens about floridation in water. She suggested that this become an agenda item at the next meeting. Mr. Lindstrom questioned Ms. Hallal about follow-up with dental professionals in the area. Ms. Hallal stated she had reviewed the information for the new filtration system which indicated flouride would be used. It is her understanding after discussing this with Mr. Barry Smith of DPW, that the Town of Medway is to receive floridation again, but did not receive information as to when it will be received. It was decided by Mr. Lindstrom to have this as an agenda item at the next meeting for further review. Mr. Lindstrom asked Ms. Harris to make a motion to review this topic at the April 4<sup>th</sup> meeting. *Ms. Harris made the motion to add the topic of floridation to the next meeting, seconded by Mr. Mill, approved by all.*
