#### **Request for Certificate of Compliance**

4 Marc Road (DEP #216-0943) and Land Disturbance Permit (LD-21-05) – proposal to upgrade the existing stormwater management system, removal of sediment from intermittent stream

No one was present to address this matter.

<u>VOTE</u>: Mr. Travalini offered a motion per the request of the applicant to continue the Request for Certificate of Compliance for (DEP #216-0943) and Land Disturbance Permit (LD-21-05) at 4 Marc Road to the March 9 meeting at 7:30PM. Mr. Blackwell seconded this motion, which passed unanimously. Blackwell: aye, Gill: aye, Narducci: aye and Travalini: aye. VOTE 4-0.

Ken McKay joined the meeting virtually at 7:42 PM.

### 7 Iarussi Way (DEP#216-0945) – proposal to install a in ground pool, patio, outdoor pavilion, in ground trampoline

No one was present to address this matter. Ms. Graziano stated everything is in compliance and recommended to issue a Certificate with conditions in perpetuity.

<u>VOTE</u>: Mr. Travalini offered a motion per the recommendation of the Conservation Agent that the Commission issue a Certificate of Compliance with the following conditions 8, 9 and 10 to remain in perpetuity. Mr. Blackwell seconded this motion, which passed unanimously. Blackwell: aye, Gill: aye, Narducci: aye, Travalini: aye and McKay: aye. VOTE 5-0.

### 35 Milford Street (LD-21-04) – proposal to construct one 2 family dwelling and one 1 family dwelling with associated stormwater management system

Cameron Bagherpour was present to discuss this matter. Ms. Graziano stated the applicant had installed the required plantings as transplants two days prior to the February 23 meeting. Mr. Travalini noted the conditions were issued in November 2021. Mr. Travalini stated he was not in favor of giving a Certificate of Compliance due to poor timing of planting as the ideal time to plant would have been six months ago. Mr. Travalini recommended to wait until April or May to see if the plants survive.

Mr. Bagherpour stated he can modify the HOA with language specifying the six plants will need to be replaced if they're found to not survive the winter to spring. Ms. Graziano stated she would need a document signed in the agreement that the HOA is aware of the specifications. Mr. Bagherpour clarified he can get the document to Ms. Graziano after running it by the attorney to modify the plan and have signatures of the buyers prior to March 9, 2023. Mr. Narducci suggested entering an agreement with a Building Department down in writing. Mr. Bagherpour clarified the new owners will sign off for maintenance on the HOA in the sale closing. Ms. Graziano stated she will go to the Building Department to have Mr. Bagherpour sign off on a plan to follow the requirements. Mr. Bagherpour will need to include all stormwater management systems and the maintenance requirements including replacing the dead plants in the rain garden. Mr. Bagherpour stated he will call Ms. Graziano to finalize.

<u>VOTE</u>: Mr. Travalini offered a motion to continue the request for 35 Milford Street (LD-21-04) to the March 9 meeting. Mr. Blackwell seconded this motion, which passed unanimously. Blackwell: aye, Gill: aye, Narducci: aye, Travalini: aye and McKay: aye. VOTE 5-0.

### 49 Alder Street (DEP #216-0837) – proposal to construct an addition to a commercial building an request for waiver of fee due to payment of application for second time

Amanda Cavaliere ws present to discuss this after. Ms. Grazinao discussed this was an old order of conditions that had been extended for covid provisions regarding a rubber roof rather than the original metal. Ms. Graziano noted the roof is done, they sent the reports on the septic cleaning and storm management system. Ms. Graziano recommended issuing a Certificate of Compliance with 10 and 12 remaining in perpetuity. Mr. Travalini discussed Ms. Graziano and the Commission had spent considerable time in site walks and overseeing the proposal. Ms. Graziano noted the fee is \$400. Ms. Cavaliere stated she understands there were multiple trips within a long process and she did submit the fee with the application.

<u>VOTE</u>: Mr. Travalini offered a motion to deny the request for the waiver of the payment for the fee for DEP #216-0837 49 Alder Street. Mr. Blackwell seconded this motion, which passed unanimously. Blackwell: aye, Gill: aye, Narducci: aye, Travalini: aye and McKay: aye. VOTE 5-0.

Mr. Arnold and Mr. Tayara were present to discuss this matter. Mr. Tayara stated he is requesting an extension of both orders for three years due to ongoing construction. Mr. Arnold stated he was present to answer any questions and noted Mr. Tayara was a good project manager keeping up with erosion controls and would make a great candidate for an extension. Ms. Graziano recommended DEP #216-0914 for an extension until June 10, 2026.

The Commission discussed responsibilities such as enforcing the Wetlands Protection Act State Law, River Protection Act and Town Bylaws written by the Commission. Mr. Travalini discussed plots of land owned by the town, constructing trails, site walks and operating in conjunction with the planning board for project timing. Ms. Gill noted there are training opportunities such as the once a year MACC conference as an environmental resource. The Commission discussed being able to adjudicate state laws, attending meetings for grants and developing action plans to present at the National Planning Conference in Philadelphia.
