## **PRESENT:**

Member Peden opened the meeting at 7:05 pm.

### **Public Comments:**

There were no comments from the general public.

### New Business:

The EDC was informed that the recent Medway Zoning Bylaw and Map were adopted at town meeting.

The EDC was made aware that that there was a departmental meeting in which there was discussion about future zoning amendments.

This included looking at the following:

- Table of dimensional uses
- Affordable Housing Bylaw Revisions
- Creating new village residential
- Refining special permit criteria
- Parking
- Finalizing the sign bylaw (public forum 2017)
- Rezoning West Street parcel for commercial development.
- Provide a map at the next meeting for discussion and recommendations.

Member Rodenhiser explained that there is a committee which is working on revisions to the Affordable Housing Bylaw. The town received a grant to get assistance from MAPC with this process. The goal is to make the formulas more easy to follow and also change the in lieu of requirements. It was suggested not to take land donations. This is still in draft form.

It was also explained that the staff within the planning department with Jack Mee are working on creating a document which would be certificate of zoning compliance. This will need further discussion. There was a question if the EDC will be able to provide input on these potential articles. Some of the non-zoning items include the following:

- Stormwater bylaw
- Street Acceptance Candlewood Drive and Island Road

- Noise bylaw
- Public access easement to get drive on Williamsburg Way to get to the Williamsburg open space parcel.

Member Yorkis informed the members that he is not in favor the stormwater bylaw and indicated that there are lawsuits going against the new MS4 requirements. Mr. Yorkis further indicated that he wishes that when the list of items was created, someone from the town would have informed him that there were items on the list which involved his interests. This included Williamsburg Way and the item involving the street acceptance of Candlewood and Island Road.

All of the items on the sheet will need further discussion and the EDC would like to be included in this discussion.
