### Clerk's Report

Mr. Alessandri briefly explained the basic process to Ms. Hillery. The bills thus far were the dues for the Association of Finance Committees (\$210) and the cost of the legal ad soliciting for new member applications (\$74.12). These bills will be paid of the Finance Committee Budget Account. The Finance Committee Reserve Fund has a beginning balance of \$100,000.

## **Chairman's Report**

Chairman Rossi reported that he and Mr. O'Neill attended the recent Open Space event. The Open Space Plan is being updated. He spoke briefly on the open space amounts from other communities, noting that Medway has less than most. The updated plan is necessary as it will be used as background material for grant applications.

Chairman Rossi reported that he believed the new Parks and Recreation Director starts on Monday. Mr. Schrader added that he would like the new chair to come in to talk about the department's plans for the coming year, possibly at the September meeting.

As Chairman Rossi will be away the week of the August Finance Committee meeting, it is likely that it will be cancelled if there are no pressing agenda items.
