Call to Order

1.0 Final Preparations for 2023 Fall Town Meeting

Review of Article 1 -- TBD Designation

Chairman Cowan reported that Article 1 [Citizen's Petition RE Firearm Discharge] was withdrawn by the petitioner; however, the withdrawal was not done in time to remove it from the Warrant. A motion to defer action indefinitely will allow the matter to come to Town Meeting again in the future. If, however, the article is voted, it cannot come back to Town Meeting for two years if it is voted down.
