Invoices:

The MRA is in receipt of a copy of an invoice for the deposit for the land purchase, pursuant to the offer and acceptance that was agreed to at the last meeting. The agreement requires a deposit of \$12,500.00 upon signing of the purchase and sale agreement for the acquisition of the New England Power Co. property.

<u>Rt 109/Trotter Drive Traffic Signal:</u>

The MRA was informed that Member Yorkis had a zoom call with State Representative Jeffrey Roy and Congressman Jake Auchincloss about funding for a traffic light at Route 109/Trotter Drive. The representatives will be advocating for the earmarks for the project after an infrastructure bill is enacted into law.

New England Power Co. Land:

The MRA was made aware that the purchase and sale of New England Power Land is moving forward. The deposit has been provided. The contract was completed for the Phase I environmental review. This may be delayed due to the snow on the ground. If the review is delayed it may also push out the closing date. There is allowed a 30-day extension. The issues

with the title continue to be worked on. The purchase and sale documents will be signed with a tentative date of March 5, 2021, tentative closing date April 9, 2021.

Site Readiness Grant:

Ms. Saint Andre reported that there has been no official word yet on the Site Readiness grant application. The MRA discussed at a previous meeting the new state grant program, One Stop for Community Growth, under which the town can apply for up to five projects. The town would need to send in a statement of intentions for each of those projects. The State would then provide feedback to the Town and direction as to what grant programs might be available. The MRA members discussed if they would like to put the Oak Grove project in for this if the \$100,000.00 Site Readiness grant does not come through.

On a motion made by Paul Yorkis, seconded by Mike Griffin, the MRA voted unanimously to move forward with the One Stop for Community Growth grant application with the inclusion of Oak Grove if the funding is not approved through the Site Readiness grant.
