To see whether the Town will vote to transfer the sum of \$40,000 from the Operational Reserve Account to the Fiscal Year 2013 Fire Department budget for the purpose of funding an additional staff member to comply with state regulations relative to Emergency Medical Services operations, or to act in any manner relating thereto.

in connection thereto, and that to meet this appropriation, the Town Treasurer, with the approval of the Board of Selectmen, be authorized to borrow, or to act in any manner relating thereto.






