# **Master Plan Update:**

On a motion made by Jack Wolfe, seconded by Glenn Trindade, the Affordable Housing Trust voted unanimously to approve, and allow the Chairman to sign the necessary documentation on behalf of the Affordable Housing Trust, and to recommend this to the Board of Selectmen.

## **Conflict of interest training:**

The Affordable Housing Trust Members were informed that the Conflict-of-Interest training needs to be completed by each member to comply with the Open Meeting Laws.

#### Glenbrook Way:

The Affordable Housing Trust was informed that there will be a lottery on June 25, 2021. There will be a mini tour of the units. The Trust wanted a reminder notice sent to them about the event. The completion date is set for September 24, 2021.
