Introduction of New Planning and Development Coordinator:

The new Planning and Economic Development Coordination is Jeremy Thompson. He provided his background to both the Trust and Committee.

Chair Sherry discussed that she would like to see Mr. Thompson working with the Trust/Committee to implement the goals of the Housing Production Plan. It would be beneficial to have assistance in working with the Planning and Economic Development Board (PEDB) in working on meeting the local needs for housing along with creating new options for housing, which may include working on housing choice legislation or increasing housing incentives at both a local and regional level.

The town is currently at 11.4% for the affordable housing percentage. The total housing units are 4,819.

Glenbrook Way Phase 2:

The Trust/Committee was informed that completion of Phase 2 of the project has been delayed due to lack of availability of electrical switching gear.

Doug Havens will be trying to reach out to Medway residents to apply for these units.

Trust member Trindade informed the Trust/Committee that he has spoken with MetroWest Collaborative Development, which is interested in developing another Medway parcel. A parcel of land, donated to the town by Charles River Bank was discussed.

39 Main St.:

There have been only 8 applications (4 of which have been approved) for these affordable units. Another 4 are being preliminarily reviewed. It was opined that it has been difficult to find qualified households to rent these units since the rent is so high.

Update on 7-5 Kingson Lane:

(Member Wolfe recused himself from the discussion item.)

The Trust/Committee discussed 7-5 Kingson Lane. There has been some work done on the railings. There has also been installation of new carpet, miscellaneous safety concerns have ben addressed and the sink has been replaced.

Member Trindade left the meeting and there was no quorum of the committee. The Committee meeting was therefore adjourned.

(Member Wolfe returned back to the meeting.)

Housing Production Plan:

The Trust/Committee would like to work with Jeremy Thompson, identifying and implementing achievable aspects of he Housing Production Plan.

Subsidized Housing Inventory:

The Trust/Committee members are in receipt of the Executive Office of Housing and Livable Communities' (EOHLC) Subsidized Housing Inventory (SHI).

Member Wolfe has mentioned at a previous meeting that the Trust/Committee should invite the state Secretary of Executive Office of Housing and Livable Communities Edward Augustus to a future meeting. A letter with an invitation to meet will be drafted.
