## Glen Brook Way:

The Trust and Committee were informed that there are no new developments regarding Glen Brook Way. The signed documents are being reviewed by all parties. The goal is to have this project completed in Spring 2021. There is likely to be a staggered lottery process for these units as the buildings become available.

## <u>6 Cutler Street RFQ:</u>

The Trust/Committee discussed at the last meeting reaching out to realtor in the Town of Medway along with surrounding towns. There were no responses to Doug solicitation of 5 local realtors. Doug Havens provided the list of contacts to Chairman Sherry. There will be further contact with the Medway Business Council and Friends of Medway. A suggestion was made to look at a Mass Housing Grant to see if it was profitable or not to see if it is worth putting one more house on site. Reaching out to Mass Housing will not cost the town any money. Doug did communicate with the Medway Fire Chief about using the site for fire drills. He was not interested in demolishing the house but rather smoke/ventilation training and survival rescue. Doug will follow-up with representatives from the Town of Millis and Medfield for advice on selling town property.

# **Kingson Lane Unit 7-5:**

The Trust/Committee discussed that the agreement with the foreclosing bank for Unit 7-5 Kingson Lane to be sold as affordable has been signed by all parties. Chapa will be signing off on the required paperwork. There has been communication that the unit is still occupied. To Doug's best knowledge, the sale of this is moving forward.

# **Affordable Housing Committee:**

There was a recommendation to ask the Board of Selectman to actively pursue getting new members to serve on the Affordable Housing Committee.

# **Role in promotion of Diversity:**

The Trust and Committee are in receipt of a 3 texts relating to the promotion of diversity. All were in agreement with the adoption of some statement with the goal of trying to invite a more diverse buyer pool of households to the Town of Medway. The Committee/Trust especially is in support of the third statement and would like to make sure we continue to reach out to all sources to provide diversity in fair marketing for future solicitations in the Town's affordable housing inventory. The Committee/Trust would like to discuss this further at the next meeting. It would be great to work on this as Timber Crest is being built. There was a recommendation for Doug to get a timeline of schedule completion for Timber Crest. The Trust/Committee would also like

an updated list of the current Affordable Housing numbers. This will be provided at the next meeting.
