New Business

1. Staff notification drill was sent to just the Chair of the Board and not the entire Board.
2. Mr. Kwok sent the Board an email about MAHB certification program for any Board member that wants to attend
3. Ms. St. Pierre dropped in on the office hours of School Committee members and mentioned they've been trying to discuss student mental health records with the Committee. There is a wellness advisory committee, which the Board could have a liaison on.

Discussion

1. Body Art Regulations – Apprenticeships and Practitioner: Mr. Kwok and the Board went through the additions and changes to the Body Art Regulations for apprenticeships and practitioners. The regulations now include new requirements for new applicants for cosmetic tattooing as well as new, detailed regulations for a

body art apprenticeship. The Board discussed the weekly hours of experience requirements for body piercings. Mr. Kwok stated he would reach out to various studios outside of Medway to see what their piercing training hours requirements are. The section on Procedure of Hearings has been revised. The section on Enforcement and Penalties is now more in line with other regulations like the animal regulations. Mr. Kwok stated the regulations will be shared with legal and then with the three different establishments in Medway once the Board is finished revising
