1. Minutes from September were approved with a motion from Jordan and a second from Jennifer.
2. 6 artists have agreed to do a tour for the virtual studio tour. Judith put the deadline for videos as mid-November. Videos will be sent to Fran Hutton Lee. Website updates were discussed as well. Erin McCarthy's email will be sent over to Judith Moffatt. Kim will also look into whether Dorinda King wants to participate.
3. Joanne has the Bridge project and naming of the bridges on the agenda for the next Board of Selectmen meeting. She will have more project information coming in November.
4. Joanne and Judith volunteered to film introductions for the Artist Spotlight videos, along with Gail and Jennifer. Names for possible future spotlights were discussed.
5. "Art Out" will need to be guided by Julie Harrington in terms of being Covid-19 safe. This will be a chance for artists to be in a spot, socially distant, in order to be making art at the same time. Karyl will write up a description and get in touch with Julie Harrington to

work out details. Kim brought up the idea of exhibiting artwork as well. Joanne discussed the idea of adding regularity to the program, making it a weekly event.

6. Library art project is moving along. Judith made illustrations, supplies have been delivered. Thanksgiving, Winter, Valentine's Day, Spring will be the four times these supplies go out through the library. Kim brought up the idea of publicizing the packages. Gail will create a write up about the project. Jordan will discuss getting CC stickers at the main CC meeting in November.
7. Judith also talked about creating a gingerbread house out of paper that children could download and print. Joanne talked about expanding that idea to offering multiple little projects that could be done as well.
8. Jordan will talk about the poster at the next meeting.
9. Jordan discussed the Sister City idea. He said that it generally isn't successful with smaller towns like Medway. Jordan is finding out more information from two other U.S. cities that had some success with the program.
10. Fairy houses on the trails were discussed. Artists could make a fairy home in designated spots. Children could create the fairies. Joanne talked about the need for teaching children how to interact appropriately with nature and natural materials. Kim asked if we could get in contact with getting the artist Pat Dougherty from Tower Hill Botanicals (website is stickwork.net/work) and see if we could get an installation here. Joanne will talk to Carol from the Community Farm and see if he would be interested in applying for a grant. She also talked about lining up these events with Soup on the Bridge next year. This will be continued to be discussed at the next subcommittee meeting.
11. Jordan talked about getting artist contact information up-to-date. He sent out an email with instructions about how to get this information.
