Thank you for submitting the proposed signage for the Charles River Pollution Control District to the Medway Design Review Committee (DRC) for review. The information was filed with the Town on September 13th, 2021 by Cam Afonso of Signs by Cam.

Pursuant to the Medway *Zoning Bylaw*, SECTION 7.2 Sign Regulations, this communication serves as the DRC's review letter regarding the proposed free-standing monument sign for the Charles River Pollution Control District facility at 66 Village Street in Medway. Please be advised that this letter does NOT constitute approval of a sign permit. You must still apply for and secure a sign permit from the Medway Building Department prior to sign installation. Do not install the sign before obtaining the required permit.

On Monday, October 4th, 2021, the DRC met with your sign fabricator, Cam Alfonso of Signs by Cam, Inc., to review the proposed monument sign for the Charles River Pollution Control District. You have proposed the following as represented in the sign designs prepared by Signs by Cam Inc. (**See Attached**).

- **Monument sign** – Double sided, 4 x 5' urethane panel with V carved, gilded lettering and piping on a tombstone form sign with colored logo in upper lunette. The proposed sign will be mounted between two 6" x 6" granite posts. Total sign surface area is 40 sq. ft. The height will be 6' and the sign will be set 2' above the ground. Landscaping is shown as four boxwood shrubs. Landscaping is limited by lack of water in vicinity. No lighting will be included.

The DRC agreed that the sign is attractive and appropriate to the residential neighborhood surroundings of this area. The Committee offers the following comments/recommendations regarding the proposed sign:

- Consider an enhanced landscape plan that includes perennial bulbs that will improve the appearance seasonally. Prepare a plan to maintain shrubbery heights below the bottom of the sign to prevent an overgrown appearance.


Thank you for your time. We are pleased to see such an attractive sign going up at this site.
