Dear Mr. Patel,

Thank you for submitting the proposed signage for Keystone Liquors to the Medway Design Review Committee (DRC) for review. The information was filed with the Town on April 13<sup>th</sup>, 2021.

Pursuant to the Medway Zoning Bylaw, SECTION 7.2 Sign Regulations, this communication serves as the DRC's review letter regarding the proposed wall façade sign for Keystone Liquors at 88 Main Street in Medway. Please be advised that this letter does NOT constitute approval of a sign permit. You must still apply for and secure a sign permit from the Medway Building Department prior to sign installation. Do not install the sign before obtaining the required permit.

On Monday, April 26, 2021, the DRC met with your representative, Gilmar DaSilva of Best Price Signs and Printing of Brockton, MA, to review the proposed signage for Keystone Liquors. You have proposed the following as represented on the sign design prepared by Best Price Signs and Printing. The sign design is undated. (See Attached).

• Replacement of the current sign with a channel letter sign, 14.5' wide by 2.5' tall for a total of 36.25 square feet. KEYSTONE will have white faces; LIQUORS will have red faces. That size conforms with what is allowed per the Zoning Bylaw. The individual letters will be attached to a raceway.

The DRC offers the following comments/recommendations regarding the proposed signs:

- Clean, paint and prepare the stucco façade where the prior sign had been installed. This will remove any ghosting from the former sign on the façade and eliminate any holes or imperfections to allow a cleaner appearance to the new sign.
- Paint the raceway to match the stucco façade color.
- Set lighting of sign to an appropriate brightness and set to a timer that will shut the sign off, after business hours.
