Dear Ms. Hopkins Dudko,

Thank you for submitting the proposed signage for Loyal Companion to the Medway Design Review Committee (DRC) for review. The information was originally filed with the Town on July 2, 2019. A revised application was provided on July 10, 2019.

Pursuant to the Medway Zoning Bylaw, SECTION 7.2 Sign Regulations, this communication serves as the DRC's review letter regarding the proposed façade and panel signage for Loyal Companion to be located 67 Main Street at Medway Commons. Please be advised that this letter does NOT constitute approval of a sign permit. You must still apply for and secure a sign permit from the Medway Building Department prior to sign installation. Do not install the sign before obtaining the required permit.

On Monday, July 15th, the DRC met with you to review the proposed signage for Loyal Companion. You have proposed the following as represented on the sign designs submitted (**See Attached**). The signs will be fabricated by National Sign Corporation of Berlin, CT.

- Facade Sign measuring 24" high x 28' wide, 56 SF total. The design features the words "LOYAL COMPANION" in all caps. The sign consists of white internally illuminated channel letters with royal blue applied faces which are individually mounted directly to the building façade. The sign is replacing the former "Especially for Pets" signage.
- A reface of the free-standing ladder sign panel at the entrance to the plaza will feature a 10.75" x 8' panel (7 SF) x 2 sides = 14 SF. The proposed design features the words "LOYAL COMPANION" in white on a royal blue background panel. The "LOYAL" logo will appear to the left. The sign is internally illuminated.

The DRC offers the following comments/recommendations regarding the proposed signs:

- The Medway DRC recommends that the façade signage be constructed and installed as proposed in the submission from July 10th.
- The proposed façade signage is legible and the font chosen is attractive. The sign is appropriate to the plaza. Make sure to clean or paint the façade once the "Especially for Pets" signage is removed to prevent any ghosting of the old sign interfering with the appearance of the new "Loyal Companion" signage.
- The ladder sign panel blue background allows for the better legibility as opposed to how the same sign would appear in the reverse (white background). Therefore, the DRC agreed with the applicant that the blue background was a good choice in this case.
- The small type for "Companion" below the "Loyal" logo at left on the ladder sign is truly too small to be legible. The applicant indicated that it is a corporate logo already in use.

You indicated that you would consider these suggestions and move ahead. You are welcome to return to a future DRC meeting for further conversation and ideas regarding signage for Loyal Companion. Please contact the Medway Planning and Economic Development office at 508-533-3291 if you would like to schedule another appointment with the DRC.

The DRC's goal is to enhance the identification value of business signs in Medway. We seek to help Medway businesses and organizations develop their signs as long-term investments, designed for sound readability with appropriate graphics and materials in a manner that suits budgetary constraints and enhances our community's appearance and appeal.




