Thank you for submitting the proposed signage for LZ Nails & Spa to the Medway Design Review Committee (DRC) for review. The information was filed with the Town by Cam Afonso of Signs by Cam on March 15, 2023.

Pursuant to the Medway Zoning Bylaw, SECTION 7.2 Sign Regulations, this communication serves as the DRC's review letter regarding the proposed wall façade sign and an insert panel in free-standing multi-tenant development monument sign for Gould's Plaza at 74 Main St, Medway. Please be advised that this letter does NOT constitute approval of a sign permit by the Town of Medway. Your sign company must still apply for and secure a sign permit from the Medway Building Department prior to sign installation. Do not install the sign before obtaining the required permit.

On Monday, March 20, 2023, the DRC met with Mr. Afonso to review the proposed signage for the LZ Nails & Spa. You have proposed the following as represented on the sign designs submitted. (See Attached).

- Wall Façade Sign 24"x120" (20SF). This sign is externally illuminated and is replacing an existing sign.
- Free-standing multi-tenant development monument sign panel is 14"x47" (9 SF total)

The DRC offers the following comments/recommendations regarding the proposed sign:

• The DRC recommends the signs be manufactured as proposed as the type, style and format of the signs fully comply with the master signage plan for Gould's Plaza.
