### Sign Design Review - Walgreens and Village Medical, 68 Main Street-

Ms. Mercier of Sign Design, Inc. started the discussion on the topic. She briefed the applicant (Walgreens and Village Medical) about the DRC's comments discussed at the 10-03-2022 meeting. The applicant has agreed to the DRC's proposed recommendation of stacking "Walgreens" and "Village Medical" in two separate lines vs. the side-by-side format of the original proposal. She confirmed the logo will be changed, and the sign will be stacked in two lines. Landscaping will be provided 3 ft on each side of the pylon. The revised visual was shared with the members. (See attached revised version.)

There was some discussion on the visibility of the text against the current proposed grey background. An option to have a darker background was discussed. The thinking was that the proposed blue color for the fonts is softer on the grey background. Ms. Affleck-Childs suggested an option of retaining the dark red background as in the existing conditions. Ms. Mercier said the applicant is looking to get away from the red background. Black piping around the word "Medical" was discussed. Some color and font options available on the Walgreens website were reviewed and discussed. There was consensus on the sign (font type, color, and background color) that was installed at the Shrewsbury location. (See attached) Members agreed on white opaque background with illuminated lettering. Ms. Clifford will draft the DRC letter to the applicant.

# <u>Site Plan Review – Sanderson View, 16 Holliston Street</u>

Applicant did not provide any information for review.

#### **OTHER BUSINESS-**

- Ms. Clifford brought up the topic on Medway Nutrition which has changed the logo on its signs that is different from version the DRC previously approved. She asked if the owner has the responsibility to inform and receive DRC approval before using the new sign/logo. Ms. Clifford and Ms. Ahlstedt said both (building façade and monument panel) signs were changed. The new sign is not legible with the color scheme and graphic. Mr. Buckley confirmed the new logo is on the Medway Nutrition Facebook page. Members noted that the business recently changed management. Ms. Affleck-Childs took note and said she'll reach out to the Building Department and the new owner for more information.
- To a question on the status of vacant Building Commissioner's position, Ms. Affleck-Childs stated the process is ongoing.
