Sign Design Review – Medway Community Farm at 50 Winthrop Street

Mr. Terramane, Medway Community Farm manager participated in the meeting along with the sign designer Mr. Cavallaro. Proposal is for a 4'x5' double sided, externally illuminated, free standing business sign. (See Attached). It will be installed on the corner of the farm entrance to the parking lot. The sign will have removable tiles and the intent is not to change the lower plaques frequently. The font size on the bottom plaques will be smaller than the main size above. Mr. Terramane said the main idea is to maximize the square footage of the sign to improve visibility. Ms. Lander commented that the sign fonts should be consistent among each other.

Ms. Affleck Childs commented that DRC has been encouraging organizations to include business addresses on free standing signs. In response, Mr. Terramane said the truck deliveries usually use the adjacent driveway that might potentially create confusion. For that reason, he was hesitant to include the business address on the proposed sign. Mr. Cavallaro suggested adding a small message indicating the correct location for the deliveries. Mr. Buckley talked about including store hours at the bottom. A square cap on top of the 6" x6" black post was discussed, and Mr. Cavallaro agreed to look into design ideas to add some type of caps. Ms. Chabot recommended using heat reflective black paint for the sign. 5'x3' cedar was discussed as an option to consider for the primary sign material.

Ms. Affleck-Childs talked about the landscaping plan. Mr. Buckley stressed that the plan should show the landscape design details. Ms. Affleck-Childs said the information in Mr. Terramane's letter has good information about the landscaping plan. The sign lights will be solar powered and will be kept on until the farm stand is open during the year. There was some discussion on the angle of light fixtures, so the glare won't conflict with moving vehicles. Lights angled towards the sign was suggested and Mr. Terramane agreed to show it on the plan. Photo overlays of the site and the plans will be submitted to the DRC by Wednesday this week. The DRC's review letter will be drafted after the committee has received that material.

DRC member's comments and concerns

Ms. Affleck-Childs said Evergreen Village decision and William Wallace final site plan will be reviewed by PEDB this week.

Adjournment

With no further business before this committee, a motion was made by Mr. Buckley, seconded by Ms. Chabot to adjourn the meeting. The motion was unanimously approved.

The meeting was adjourned at 7:42 p.m.





Ms. Affleck-Childs:

The manufacturer Cavallaro Signs LLC has been contracted to build and install a new, larger sign at the address above. They have created and installed other signs in Medway and know the guidelines put out by the DRC.

In accordance with those guidelines we will affect landscaping to complete the professional and pleasant look of our sign. We will spread wood chip mulch in a three-foot ring around and under the new sign. In order to make it match our current landscaping we will also plant native perennial plants and flowers that will need minimal upkeep. These will be in a tighter ring around the base of the sign and planted into the wood chips.

In addition, we will install solar powered external lights to illuminate the sign. These will also be placed in the wood chips in order to better disguise their appearance.
