Dear Mr. Li,

Thank you for submitting the proposed signage for Angel Nails & Spa to the Medway Design Review Committee (DRC) for review. The information was filed with the Town on Thursday March 15<sup>th</sup>, 2018.

Pursuant to the Medway Zoning Bylaw, SECTION 7.2 Sign Regulations, this communication serves as the DRC's review letter regarding the proposed façade and panel signage for Angel Nails & Spa, 74 Main St, located at Gould's Plaza. Please be advised that this letter does NOT constitute approval of a sign permit. You must still apply for and secure a sign permit from the Medway Building Department prior to sign installation. Do not install the signs before obtaining the required permit.

On Monday, April 2nd, the DRC met with your sign fabricator, Cam Afonso from Signs by Cam, to review the proposed signage for the Angel Nails & Spa. You have proposed the following as represented on the sign designs submitted (**See Attached**).

- Facade Sign measuring 2' high x 10' wide, 20 SF total. The design features the word "Angel" at left, in script, and "NAILS & SPA" at the right, bold. The sign is designed in accordance with the Master Signage Plan for Gould's Plaza and uses the prescribed Burgundy font on Almond panel color scheme. The sign will be externally illuminated.
- Double sided panels are proposed for the multi-tenant ladder sign at the entrance to the plaza. Two 12" x 48" panels are proposed, for a total of 8 SF. The design features the word "Angel" at top left, in script, with an accent line, and "NAILS & SPA" across the panel, bold. The sign is designed in accordance with the Master Signage Plan for Gould's Plaza and uses the prescribed Almond font on Burgundy panel color scheme. The sign will be internally illuminated.


