Thank you for submitting the proposed signage for Domino's at 124 Main Street to the Medway Design Review Committee (DRC) for review. The information was filed with the Town on April 5, 2017.

Pursuant to the *Medway Zoning Bylaw*, SECTION 7.2 Sign Regulations, this communication serves as the DRC's review letter regarding the proposed internally illuminated wall sign for Domino's located at 124 Main St. Please be advised that this letter does NOT constitute approval of a sign permit. Your sign company must still apply for and secure a sign permit from the Medway Building Department prior to sign installation.

On Monday, April 24, 2017, the DRC met with Cam Afonso from Signs by Cam, to review the proposed signage for Domino's. You have proposed the following as represented on the revised sign design as submitted. **See Attached.**

- Wall/Façade Sign measuring 33" high x 130" wide for a total of 29.79 SF comprised of individual channel letters.
- The sign will be installed in the same location on the building as the existing sign on the existing brackets.
- The raceway behind the channel letters will be painted brown to match the façade shingles.

The DRC has no comments for improvements on this sign. However, please note that if the building façade should undergo renovations at a future date, the DRC would expect the building owner or their representative, to return to the DRC to discuss a master signage plan for the three-tenant building as part of the site plan review process.
