Thank you for submitting the proposed new signage for Community Pediatrics of Medway at 116 Main Street to the Medway Design Review Committee (DRC) for review. The information was filed with the Town on July 11th, 2018.

Pursuant to the Medway Zoning Bylaw, SECTION 7.2 Sign Regulations, this communication serves as the DRC's review letter regarding the proposed wall façade sign and a 2-sided panel on the free-standing multi-tenant development monument sign for Drybridge Crossing at 116 Main ST. Please be advised that this letter does NOT constitute the Town's approval or issuance of a sign permit. You must still apply for and secure the required sign permits from the Medway Building Department prior to sign installation. Do not install the signs before obtaining the required permit.

On Monday, July 16, 2018, the DRC met with you to review the proposed signage for Community Pediatrics of Medway. The signage pertains to a rebranding of Tri County Medical Associates into Milford Regional Physician Group. You have proposed the following as represented on the sign designs submitted (**See Attached**).

- Wall Façade Sign 36" x 118" (29.5SF)
- Free-standing multi-tenant development monument sign panel is 12" x 71.75" (6 SF per side for 12SF total)

The DRC offers the following comments/recommendations regarding the proposed signs:

• The DRC recommends the signs be manufactured as proposed.
