RE: DRC Sign Design Review Verizon - Wall Façade Sign 92 Main St – Medway, MA 02053

Dear Mr. Abbas,

Thank you for submitting the proposed signage for Verizon to the Medway Design Review Committee (DRC) for review. The information was filed with the Town on November 5, 2018 by Kerry Neal of Hired Hand in Ashby, MA.

Pursuant to the Medway Zoning Bylaw, SECTION 7.2 Sign Regulations, this communication serves as the DRC's review letter regarding the proposed facade sign located at 92 Main ST. Please be advised that this letter does NOT constitute approval of a sign permit. You must still apply for and secure a sign permit from the Medway Building Department prior to sign installation.

On Monday, December 3rd, the DRC met with Sandy Leavenworth of Hired Hand to review the proposed signage for Verizon. See Attached. The following sign is proposed represented on the sign designs submitted.

• A wall façade sign measuring 131"H x 29"W for a total area of 26.38 SF, comprised of internally illuminated individual channel letters of the business name and logo with a raceway painted to match building façade. Day/night vinyl will be applied to the front of the sign such that the letters appear black during the daytime and white at night.

The DRC offers the following comments/recommendations regarding the signs for Verizon:

- The DRC recommends that the sign be fabricated as proposed. The DRC is pleased with the simple, crisp design.
- The DRC recommends painting the wall behind the sign if any shadowing remains from the previous tenant's sign. Further, any holes from the previous sign should be filled and painted as well.

This will require another application for a separate building permit. If the name and logo match the new façade sign, the DRC does not need to review the design of the insert panels.

Mr. Leavenworth indicated that you would consider these suggestions and move ahead. You are welcome to return to a future DRC meeting for further conversation and ideas regarding signage for Verizon. Please contact the Medway Planning and Economic Development office at 508-533-3291 if you would like to schedule another appointment with the DRC.

The DRC's goal is to enhance the identification value of business signs in Medway. We seek to help Medway businesses and organizations develop their signs as long-term investments, designed for sound readability with appropriate graphics and materials in a manner that suits budgetary constraints and enhances our community's appearance and appeal.


