DRC Meeting Minutes:

<u>01-22-2018 minutes</u>: A motion was made by Mr. Buckley to approve the minutes from the 01-22-2018 DRC meeting as amended, seconded by Ms. Walsh. The motion was approved. Mr. Gay abstained as he was not present at that meeting.

Sign Design Review - Medway Eye Care, 89 Main Street:

Members reviewed the Medway Eye Care sign design (*See Attached*). They were OK with the sign in general. They commented that the letters were placed high on the sign panel and recommended centering them. Ms. Chabot will write the DRC's review letter.

Announcements/News

❖ Members were reminded about the Medway Business Council meeting to be held on February 21st, 2018 (7:30-9:00AM at VFW). One of the agenda items is a discussion on "Elements of Good Design/ Means to Achieve Them". There was discussion on DRC member(s) attending this meeting and saying few words about the work the Committee does. Members said it would be a good platform to let the businesses and the Council know that DRC can help in any design related matters.

Next steps on Community Message Board Sign

- ❖ Mr. Connolly worked with Poyant Signs to create a mockup of Choate Park sign and estimate based on DRC discussions.
- ❖ There was some more discussion at this meeting on the monument design.
- ❖ Mr. Kendall suggested keeping the monument wall and the message sign as two separate pieces.
- ❖ Members discussed that plan notes on the Rt. 109 project should be used for the message signs as well. Mr. Buckley suggested having a better description of the wall in the plan notes.
- Discussion included the type of stones that should be used in building the wall.
- ❖ Members discussed moving the sign closer to the wall/ pillar and also to reduce the space between the base and the bottom of the sign.
- ❖ Mr. Kendall agreed to prepare a 3D model of the monument with individual stones. He talked about landscaping around the bottom of the pillars/monument. Ms. Chabot said there isn't enough space around to include any landscaping. Planters around the base was discussed as an option.
- ❖ Satin bronze edging for the sign was discussed as an option.
- ❖ Members agreed that a stone cap will be added to the sign base and column. Base below the sign should be narrower than the columns. Include notes about stone type and construction to match Rt. 109 wall.
- ❖ Proposed sign locations in the attached are incorrect. Decrease space between LED sign and monument. The height of the monument wall (3° 6" including stone cap) will be adjusted to match the height of the LED sign.
- ❖ Ms. Affleck-Child asked about the bidding process for the LED sign and monument. Discussion ensued if the monument and message sign installation should be done by different contractors.
- ❖ Mr. D'Amico said he will consult with Amarillo (Rt. 109 project contractor) to find out about their stone supplier. The idea is to maintain consistency in the stone types used for the Rt. 109 and the proposed monument.

- ❖ There was a question on the timeline for the installation of the monument and message sign. Mr. D'Amico responded the project is anticipated to begin/ installed in spring 2019 when the Rt. 109 project is complete.
- ❖ With the quote for the sign/ monument from Poyant Signs, request for funding will be made at 2018 fall town meeting.
- ❖ Ms. Chabot asked if the design has to be presented at the town meeting and the response was no.
- ❖ Choate Park sign will be a square bronze plaque. Layout will be similar to the town sign.

Shelly Wieler – Medway Energy Committee

- ❖ Ms. Wieler, liaison from the Energy Committee attended the meeting.
- ❖ She talked about the Energy Committee's mission and goals. Energy efficiency should be considered and included in all Town projects. She talked about taking steps to reduce carbon footprint by choosing energy efficient products in all the projects that come before DRC.
- ❖ She said members should ask for electric vehicle charging stations when parking lots are involved in the projects.
- ❖ She talked about including solar panels in the projects. Ms. Walsh talked about the recent application from Milway Auto Parts business which envisions installing solar panels in the future.
- ❖ She explained the Community Aggregation concept for Electric Supply.
- **!** Energy Committee is encouraging residents to get Mass Save program to do the audits.
- ❖ She quickly touched on the canopy solar panels project which had been proposed at the high school. Program was introduced two years back but did not take off due to safety concerns.
- ❖ Ms. Chabot asked if the Planning Board could mandate some percentage of energy efficiency in all new projects and the response was no.
- ❖ Ms. Wieler said Energy Committee is looking for two new members and asked the members to spread the word.

Discussion on items in the DRC 2017 Annual Report for the 2017 Annual Town Report-

❖ Ms. Affleck-Child summarized the list of all sign reviews DRC conducted in 2017. This is for Medway Annual Report for 2017. Mr. Buckley agreed to work on the bullet points that will be included in the 2017 Annual report.

Medway Shopping Center-Tenant Panel Signs

- ❖ A letter/ note was sent to Medway Place shopping center asking for a re-arranged layout of the panel signs for the new multi-tenant development signs.
- ❖ In response to that request Heidi LeGassie of BARLO SIGNS sent the current plans for the sign panels (*See Attached*). Members reviewed the pdf provided.
- ❖ Ms. Affleck-Childs stated that the submitted layout addresses some of the DRC's recommendations included in its September 16, 2017 review letter.
- ❖ Mr. Buckley asked if the sign rendering was created by Eric Lawless, the current property manager. He wondered if the new manager was even aware of the DRC's September 2017 letter. Ms. Affleck-Childs she doesn't know about that.
- * Members did not agree with the organization of the business names and the white lines around each individual business sign panels.
- * Recommendation was made to reduce the font size of "Managed by Diversified Funding Inc." and keep the email address fonts regular without making them bold.

- ❖ There was discussion on recommending the removal of "Cafe & Play" under the Tumble Beans business name.
- ❖ The only illumination for the panel will be spotlights from the bottom.
- ❖ Members did not approve the illustration of the planting provided in the pdf and asked for the landscape (lighting included) site plan.
- ❖ The DRC did not approve the signs as presented. Mr. Buckley will draft a new review letter to forward to the property owner. Reference to the September 2016 letter will be included in the new one.

Other Business as may come before the Committee

- ❖ Mr. Kendall said he was informed of unnecessary night lighting at the back of Walgreens which results in light spillage. Members said it was for security purposes. Mr. Gay said it's important to understand if the issue is with light spillage off the or with visibility of the light fixtures.
- ❖ Ms. Affleck-Child said the PEDB public hearing on Milway Auto Parks will begin next week (February 13, 2018).

With no further business before this committee, a motion was made by Mr. Buckley to adjourn the meeting, seconded by Mr. Gay. The motion was unanimously approved.





It was great to see you last week.

I wanted to chat with you about next steps to finalize the individual designs and layout for the tenant panel signs on the new wall signs at Medway Shopping Center/Place. I called to leave a message, but your phone message box was full.

The last time the Design Review Committee reviewed the tenant signs was September 2016. Since then, some tenants have changed and the arrangement/positioning of the sign panels has likely been modified as well. Further, the DRC provided some guidance on recommended changes to improve the readability of the tenant sign panels and we hope that the updated plan incorporates those changes. Please note, the original permit for the wall signs dates back to March 2016.


