#### **Meeting Minute**

12/19/2019: A motion was made by Ms. Rossi to approve the minutes of 12/19/2019 meeting as amended, seconded by Mr. Tudino. All were in favor.

### Community Education - Karen Niemczyk

• Ms. Niemczyk discussed the fees and cost of the Summer adventure programs and the Summer 2020 programs. She handed out a detailed print of the cost and the details. The Board Members reviewed and came up with a price for each individual.

A motion was made by Mr. Murphy that there would be no change in the fee for summer adventures program at the rate of \$15 per participant/program capping at \$7,500 but that the additional summer programs of 2020 would be \$6.00 a person per registration fee, seconded by Mr. Tudino. All were in favor.

#### **Cassidy Batting Cage Replacement**

- Rich Coakley discussed the capital project to tear down the fences and put up new batting cages (similar to the Middle school batting cages) the price for 3 batting cages is between \$12,000 \$17,000.
- Ms. Rossi questioned if the batting cages were mobile and if they could be relocated in the future if needed. Mr. Coakley discussed the current location is central and safe for the kids.
- Rich Coakley will have 3 quotes for the next meeting, to finalize and get the project installed before April 26, 2020 for opening day.
