At 6:34 PM Chairman Rossi called the meeting to order. He declared that there was a quorum with six members present.

- Mr. Rossi quickly went over the handout with budget amendments that need Committee's vote before presenting them at the special town meeting tonight.
- Mr. Rossi said the control totals in the budget have not changed. Everything in blue color (in the budget sheet) have changed. Members briefly went over the line items that changed.
- Page 2- Salary reserve changed from \$180K before the collective bargaining process to \$22,000.
  The amount was reduced and the difference was spread out among different salary lines.
- A motion was made by Mr. Ashok to recommend the approval of FY2019 budget with changes to salary reserve and communications relative to collective bargain, seconded by Mr. Schrader. All were in favor. It was voted 6-0-0.
