## Election of Officers

<u>Chairman</u> - Ms. McCarthy was nominated by Ms. Donahue and seconded by Ms. Larrabee. There being no other nominations, the nominations for Chairman were closed upon the motion of Ms. Larrabee and seconded by Mr. Rice. The election of Ms. McCarthy was unanimous.

<u>Vice Chairman</u> – Ms. Donahue was nominated by Ms. Larrabee and seconded by Ms. McCarthy. There being no other nominations, the nominations for Vice Chairman were closed upon the motion of Mr. Rice and seconded by Ms. Larrabee. The election of Ms. Donahue was unanimous.

<u>Treasurer</u> – Ms. Larrabee was nominated by Mr. Rice and seconded by Ms. McCarthy. There being no other nominations, the nominations for Treasurer were closed upon the motion of Mr. Rice and seconded by Ms. McCarthy. The election of Ms. Larrabee was unanimous.

<u>Assistant Treasurer</u> – Mr. Rice was nominated by Ms. Larrabee and seconded by Ms. McCarthy. There being no other nominations, the nominations for Vice Treasurer were closed upon the motion of Ms. Larrabee and seconded by Ms. McCarthy. The election of Mr. Rice was unanimous.

The Minutes of the May 12, 2021 Regular Meeting were approved upon the motion of Ms. Donahue and seconded by Ms. Larrabee.
