## SPECIAL TOWN MEETING

Monday, September 29, 1952

The meeting was called to order at 8 P.M. by A. T. Handverger, Moderator. The reading of the warrant was dispensed with and it was voted:

Article 1. Voted that the Town transfer the sum of \$976.00 from the Highway Machinery Account to the Highway Machinery Operating Account.

Article 2. Voted that the town raise and appropriate, cr transfer from unappropriated available funds in the Treasury the sum of \$100.00 for the use of the Zoning Board.

Article 3. Voted that this article be dismissed.

Article 4. Voted that the Town accept Sections 81 a to y of Chapter 41 of the General Laws and that there be established a Planning Board of five members in the Town of Medway, said Board to be elected at the next Annual Town Election for terms of one, two, three, four and five years, and thereafter one member shall be elected each year for a term of five years and that until such Board is qualified by election at the next Annual Town Election, the Board of Selectmen shall act as a Planning Board.

Article 5. Voted that the Selectmen be authorized to sell at public auction the overhead doors of Station 2 of the Fire Department.

Article 6. Voted that the Selectmen be authorized to sell at public auction the former Police Lockup.

Article 7. Voted that the proposed revision of the By-laws be mimeographed or printed and a copy mailed to each box holder in the Town and that the matter be brought up at a public hearing before the meeting at which they are to be adopted.

The meeting adjourned at 8:55 P.M.
