- a. **For Consideration: Vote to increase school lunch prices for the 2023-2024 School Year by \$.25 for regular full price lunch and no increase for reduced lunch. The current price for elementary school lunch is \$3.05 and \$3.30 for Middle and High School.**
- b. **For Consideration: Approval of Names to be Placed on the Burke-Memorial School Plaque-** School Committee members received the nominations for names to be added to the Burke Memorial Plaque.
- c. **For Consideration: To approve the Side Letter of Agreement Department Head Positions at Medway High School,** between the School Committee and the Medway Federation of Teachers, Local 3645, AFT-AFL-CIO (Unit A), for the period of August 21, 2022 through August 20, 2025.

- d. **For Consideration: Approval of Expanded Kindergarten and Grade One Transportation**- The District is requesting that consideration be given to expand eligibility of regular transportation to virtually all Kindergarten and Grade One students for the 23-24 school year. Current policy EAAA and EEA allows for regular transportation for students in grades K and 1 if they live further than one mile of McGovern Elementary School. This approval would expand eligibility to nearly all students. This is possible because McGovern is the third tier of buses, and additional bus routes, if necessary, could be accommodated at no additional cost to the district.
