The Chair has collated and summarized the individual comments and completed a summary evaluation document, as required by DESE.**

- b. **For Consideration: Special Education Program Plan Statement (SEPPS) Approval - The federal special education law, the Individuals with Disabilities Education Act (IDEA-2004)**
