**Proposed Amendments to Medway Zoning Map**  
**Tuesday, March 26, 2024**

Pursuant to G.L. c. 40A, §5, the Town of Medway Planning and Economic Development Board (PEDB) will conduct a public hearing on **Tuesday, March 26, 2024, at 7:00 p.m.** at Sanford Hall, located in Medway Town Hall at 155 Village Street, Medway, to receive comments on a proposed amendment to the Medway Zoning Map by re-zoning the following properties to Energy Resource District: Assessors' Parcels 66-005, 66-008, 65-027, 65-028, 65-031, 65-033, 65-034, 65-035, 65-036, and 75-003.

The proposed amendment has been prepared for inclusion on the warrant for consideration at the May 13, 2024, annual town meeting. The specific article number will be provided as the Select Board finalizes the warrant and assigns warrant article numbers.

Drafts of all proposed amendments are on file at the offices of the Town Clerk and the Community and Economic Development Department at Medway Town Hall, 155 Village Street, and may be reviewed during regular business hours.
