Notice is hereby given that the Medway Planning and Economic Development Board (PEDB) will conduct a public hearing pursuant to G.L. c. 41 § 81T on **Tuesday, March 12, 2024 at 7:45 p.m.** at Sanford Hall, located in Medway Town Hall at 155 Village Street, Medway, to consider an application from Mark Bitrolff for an approval of a residential Definitive Subdivision located at 37 Holliston Street (Assessor Parcel No. 50-037) in the Agricultural-Residential (AR-II) Zoning District.

The application proposes a division of the existing lot into two separate lots for the purpose of building an additional single-family home. Both lots have frontage on an existing way; no new ways are being proposed.
