NOTICE of PUBLIC HEARING

98, 108, 114 Main Street

The Medway Planning and Economic Development Board will conduct a public hearing pursuant to G.L. c. 40A on **November 28, 2023, at 7:00 p.m.** at Medway Town Hall, 155 Village Street, in Sanford Hall, to consider an application from Medway Realty, LLC for property located at **98, 108, and 114 Main Street**, Assessor Parcels No. 40-055, 40-056, 40-057, (Medway Plaza) in the Central Business District.

The application is for a special permit pursuant to Zoning Bylaw Section 10.2.D.2.d to allow temporary use of a portion of the off-street parking for the commercial use of food trucks (not to exceed two at a time), and for holiday tree sales.

Copies of the petition and associated materials are on file with the Medway Town Clerk and the Community and Economic Development offices at Medway Town Hall and may be inspected during regular Town Hall office hours.
