Notice is hereby given that the Town of Medway **Zoning Board of Appeals** will conduct a **Public Hearing** on **Wednesday, March 06, 2024** at **7:30 P.M.**, in **Sanford Hall** at the **Medway Town Hall, 155 Village Street, Medway, MA** on an application from **GBW Senior Apartments, LLC**, with respect to property located at **31, 33, 37 West Street**, Assessor Parcel Nos. 66-001, 66-002, 66-003, 65-024, 65-026 in the Agricultural Residential II (AR-II) Zoning District.

The application is a request for modification of the Glen Brook Way comprehensive permit to waive Section 7.1.2.E of the Zoning Bylaw with respect to overnight lighting requirements in accordance with the plan submitted.
