NOW THEREFOR, the Select Board hereby repeal any and all Traffic Rules, Regulations, and Orders previously approved by the Select Board and adopt revised Traffic Rules and Regulations as attached hereto.

ARTICLE I: DEFINITIONS

For these Rules and Regulations, the words and phrases used herein shall have the following meanings except where the context clearly indicates a different meaning.

Bicycle Lane: Any area or space except sidewalks set aside within a roadway for the exclusive use of bicyclists or pedestrians and which has been indicated by signs or markings.

Bus: Any vehicle designed for carrying more than (9) Passengers and used primarily for the transportation of people.

Bus Stop: An area in a roadway set aside for the boarding of or alighting from and the parking of buses.

Caution Signal: A flashing yellow signal having the same general function as a warning sign.

Channelizing Island: A traffic island located to guide traffic along certain paths.

Crossover: An opening in a channelizing island that connects both sides of a divided roadway.

Crosswalk: That portion of a roadway ordinarily included within the prolongation or connection of curb lines and property lines at intersections, or at any portion of a roadway clearly indicated for pedestrian crossing by lines on the road surface or by other marking or signs.

Curb Marking: That portion of curbing, the painting of which has been duly authorized by the (Director of Public Works) or (the Select Board with the written direction of the Director of Public Works (DPW).

Department: The Massachusetts Department of Transportation (DOT), Highway Division.

Department of Public Works: The Medway Department of Public Works unless indicated otherwise.

Emergency Vehicle: Fire, police, ambulance, and emergency vehicles of federal, state, or municipal departments or public service corporations as are commonly recognized as such.

Fire Lane: A lane designated for fire apparatus access in accordance with General By-law 11.1.

Funeral: Any procession of mourners properly identified as such accompanying the remains of a human body.

General Laws: The Massachusetts General Laws (M.G.L.) as adopted by the State Legislature and approved by the governor.

Heavy Commercial Vehicle: Any commercial vehicle of two and one-half (2 ½) ton capacity or greater.

Intersection: The area embraced within the extensions of the lateral curb lines, or if none, then the lateral boundary lines of intersecting ways as defined in Chapter 90, Section 1 of the General Laws. The rules and regulations herein contained governing and restricting the movement of vehicles at and near intersecting ways shall apply at any place along any way at which drivers are to be controlled by traffic control signals whether or not such place is an intersection as herein defined.

Lane: A longitudinal division of a roadway of sufficient width to accommodate the passage of a single line of vehicles, whether or not such lane is indicated by pavement markings.

Manual of Uniformed Traffic Control Devises (MUTCD): The latest edition of the document, as published by the U.S. Department of Transportation, federal Highway Administration.

Officer: Any police officer or other person authorized to direct or regulate traffic or to make arrests for violations of traffic regulations.

One-Way Highways: Roadways or streets, designated by these Rules and Regulations as one-way and upon which vehicular traffic may move only in the direction indicated by signs or pavement markings.

Parking: The standing of a vehicle, whether occupied or not, other than for the temporary purpose of and while actually loading or unloading, or in obedience to an officer or traffic signs or signals, or while making emergency repairs, or is disabled, while arrangements are being made to move such vehicle.

Pavement Marking: Any painted line, legend or marking placed upon a roadway to direct or regulate traffic and which has been authorized by the Department of Public Works.

Pedestrian: Any person afoot or riding on a conveyance moving by human muscular power, except bicycles or tricycles, as defined in Chapter 90, Section 1 of the General Laws.

Person: The word "person" shall mean and include any individual, firm, partnership, association, or corporation.

Railroad Crossing: Any Intersection of ways with a railroad right of way.

Roadway: That portion of a street or highway between the regularly established curb lines exclusive of shoulders, improved and intended to be used for vehicular traffic.

Safety Zone: Any area or space set aside within a roadway for the exclusive use of pedestrians and which has been indicated by signs, lines, or markings, having the written approval of the Department.

Select Board: Duly elected Town of Medway Select Board.

Service Zone: An area duly marked and set aside for the accommodation of commercial and transient vehicular traffic engaged in the loading and unloading of materials.

Sidewalk: That portion of a street or highway set aside for pedestrian travel, including any area between the edges of a travel way and edge of sidewalk.

Sparsely Settled District: Any area that does not meet the definition of a Thickly Settled District as defined in Chapter 90, Section 1 of the General Laws.

Stop Line: A solid white pavement marking extending across a lane to indicate the point at which a stop is required to be made.

Stop Sign: A red, octagonal sign, placed only when duly authorized, to indicate the point at which a vehicle must stop.

Stop Signal: A flashing red signal having the same function as a stop sign.

Street or Highway: The entire width between property lines of every way open to the use of the public for the purposes of travel.

Street Marking, Official: Any painted line, legend, marking or marker of any description painted or placed upon any way which purports to direct or regulate traffic and which has been authorized by the Select Board and which has the written approval of the Department.

Thickly Settled or Business District: The territory contiguous to any way which is built up with structures devoted to business, or the territory contiguous to any way where dwelling houses are situated at such distances as will average less than two hundred feet between them for a distance of a quarter of a mile or more.

Tow Zone: The area duly marked where any vehicle left unattended can be removed as ordered by the chief of police or the director of public works or their designee.

Town Manager: The individual appointed by the Select Board as the Chief Administrative Officer and appointing authority of the Town of Medway pursuant to Chapter 5 of the Medway Town Charter.

Traffic: Pedestrians, ridden or herded animals, vehicles, street cars or other conveyances either singly or together while using any street or highway for the purpose of travel.

Traffic Control Area: Any area along any way, other than an intersecting way, at which drivers are to be controlled by traffic control signals.

Traffic Control Signals: All signals conforming to the standards as prescribed by the Massachusetts Highway Department, erected by authority of a public body or official having jurisdiction for the purpose of directing or warning traffic.

Traffic Island: Any area within a roadway which is not intended for use by vehicular traffic.

Traffic Signs, Official: All signs, markings, and devices other than signals, consistent with these Rules and Regulations, and which conform to the standards prescribed by the Manual on Uniform Traffic Control Devices (M.U.T.C.D.) and placed or erected by authority of public body or official having jurisdiction or in the case of a state highway the Commonwealth of Massachusetts for the purpose of guiding, directing, warning, or regulating traffic.

Traffic Signals, Official: All signals, conforming to the standards as prescribed by the Department not inconsistent with these rules and orders, placed or erected by authority of a public body or official having jurisdiction, for the purpose of directing or warning traffic.

Unposted Roadway: Any roadway that does not have a speed regulation identifying the lengths and speed limits.

U-Turns: The turning of a vehicle by means of a continuous left turn whereby the direction of such vehicle is reversed.

Vehicle: Every device in, upon or by which any person or property is or may be transported or drawn upon a highway, including bicycles when the provisions of these rules are applicable to them, except other devices moved by human power or used exclusively upon stationary rails or tracks and devices which derive their operation from stationary overhead wires.

Vehicles, Commercial: Any vehicle being used in the transportation of goods, wares or merchandise for commercial purposes.

Vehicle, Heavy Commercial: Any commercial vehicle of over two and one-half (2½) ton carrying capacity.

Yield Sign: A red, triangular sign, placed only when duly authorized, indicating that approaching vehicles must either slow down or stop when necessary to avoid interfering with conflicting traffic.

ARTICLE II: AUTHORITY AND DUTIES OF POLICE AND SELECT BOARD

Section 1. Select Board Authority to Promulgate Rules and Regulations

The Select Board is authorized by Massachusetts General Laws Chapter 40 § 22 and by the Town of Medway Charter, Section 3-2-2 to establish Traffic Rules and Regulations for the Town of Medway.

Section 2. Issuance of Permits

It is the purpose of this regulation to ensure, through the police powers of the Town, that all citizens are able to enjoy their rights of free speech and public assembly to the maximum extent possible consistent with maintenance of public peace, order, and safety. It being the policy of the Town Government that all authorities involved in the permitting process and the enforcement of this regulation do so with the specific goal and purpose of safeguarding those and other civil rights of permit holders, participants in the event, and the general public regardless of race, religion, sex, sexual preference, national origin, or political belief.

The Select Board is hereby authorized to issue a permit to any person(s) or group of persons for any lawful and peaceful assemblage, demonstration, or procession on any street, roadway or public land in the Town of Medway. Such permit may be granted upon the filing of a request in writing with the Select Board at least ten (10) days prior to the aforesaid assembly, demonstration or procession. The issuing authority may revoke the permit at any time, for violations of the statutes of the Commonwealth and the ordinances or by-laws of the Town, or for disturbances to the public peace, order and safety. Issuance of such permit does not preclude other town department specific permits. Any costs to the town for providing police services to the permittee shall be paid to the town by such permittee in advance. Any damage sustained by the town shall be the responsibility of the permittee. No person shall be denied access from the area under permit, unless the Medway Police Department deems such access to be under permit, unless the Medway Police Department deems such access to be contrary to the town's interest in preserving the public order, peace, and safety.

Section 3. Officers to Direct Traffic

It shall be the duty of officers designated by the chief of police to enforce the provisions of these Rules and Regulations. Such officers are hereby authorized to direct all traffic either in person or by means of visible or audible signal in conformance with the provisions of these Rules and Regulations provided that in the event of a fire or other emergency, to expedite traffic or safeguard pedestrians, employees of the Fire Department or Department of Public Works may direct traffic as conditions may require notwithstanding the provisions of these Rules and Regulations.

Section 4. Police May Temporarily Close Streets

The chief of police is authorized to temporarily close any street or highway in an impending or existing emergency, or for any lawful assemblage, demonstration or procession provided there is reasonable justification for the closing of such street.

Section 5. Police May Temporarily Prohibit Parking

The chief of police is hereby authorized to temporarily prohibit parking on any street or highway or part thereof in an impending or existing emergency, or for a lawful assemblage, demonstration or procession provided there is reasonable justification for such prohibition. Vehicles parked in places where parking is prohibited may be moved by or under the direction of an officer.

Section 6. Obedience to Police

Operators of vehicles shall comply with any lawful or reasonable order, signal, or direction of any officer.

Section 7. Exemptions

The provisions of these Rules and Regulations shall not apply to operators actually engaged in work upon a street or highway closed to travel or under construction or repair, to officers, when engaged in the performance of their public duties, nor to drivers of emergency vehicles while operating in an emergency and in performance of public duties when the nature of the work or any of these necessitates a departure from any art of these Rules and Regulations. These exemptions shall not, however, protect the operator of any vehicles from the consequence of reckless disregard of the safety of others.

Section 8. Chief of Police to Make Annual Crash Report

The chief of police shall make an annual report to the Town Manager and the Select Board, concerning the crash situation in the Town, including pertinent data and identification of areas of concern accompanied by his or her recommendations.

Section 9. Emergency and Experimental Regulations

For purposes of trial, the Select Board, or the Town Manager as its designee, may make temporary rules regulating traffic, or test actual conditions, traffic signs, signals, markings or other devices. No such emergency or experimental rule regulating traffic shall remain in effect for a period of time longer than sixty (60) days.

ARTICLE III: TRAFFIC SIGNS, SIGNALS, MARKINGS AND ZONES

Section 1. Traffic Signs and Signals

The director of public works is hereby authorized, and as to those signs and signals required hereunder it shall be his duty to place and maintain all official traffic signs, signals, and markings. All signs, signals and markings shall conform to the standard as prescribed by the MUTCD or the department.

Sections 3 and 4 of Article II and Sections 2 to 4 inclusive of Article IV relating to parking and Section 15 of Article VII concerning turning, and Schedule #4 pertaining to exclusions, shall be effective only during such time as official signs are erected and maintained designating the provisions of such sections and located so as to be easily visible to approaching

drivers. Sufficient numbers of such signs must be provided so that a car cannot be parked in a limited or prohibited parking place without having the legend side of such a sign, visible and clearly setting forth the parking regulation.

Section 2. Display of Unauthorized Signs, Signals, and Markings Prohibited

It shall be unlawful for any person to place, maintain or display upon or in view of any street any unofficial sign, signal or marking which purports to be or is an imitation of or resembles an official traffic sign, signal or marking, or which attempts to direct the movement of traffic, or which hides from view any official sign or signal. The chief of police and the director of public works is hereby empowered to remove any such sign, signal or marking or cause it to be removed without notice.

Section 3. Interference with Signs, Signals or Markings Prohibited

Any person who willfully defaces, damages, moves, obstructs, or interferes with any official traffic sign, signal, street sign or marking shall be subject to full restitution for the cost of replacing the sign, criminal prosecution, or both.

<u>Section 4. Location of Bus Stops, Taxicab Stands and Service Zones</u>

The location of all bus stops, taxicab stands, and service zones shall be specified by the Select Board.

Section 5. Obedience to Traffic Signs and Signals

No operator of any vehicle shall disobey the instructions of any official traffic control sign, signal or legend unless otherwise directed by a police officer.

ARTICLE IV: STOPPING, STANDING, PARKING

Section 1. General Prohibitions

No person shall park a vehicle and no person shall allow, permit, or suffer any vehicle registered in his or her name to be parked in any of the following places:

- (a) Within an intersection.
- (b) Upon a sidewalk.
- (c) Upon or within ten (10) feet of any crosswalk.
- (d) Upon the roadway in a sparsely settled district.
- (e) Upon any roadway where the parking of a vehicle will not leave a clear an unobstructed lane at least ten (10) feet wide for passing traffic.
- (f) Adjacent to any center division strip or island upon and being a part of any street or highway.
- (g) Within a crossover.
- (h) Upon a roadway where parking is permitted unless both wheels on the right side of the vehicle are within twelve (12) inches of the curb or edge of the roadway, except on those streets that are designated as oneway streets. On such one-way streets vehicles shall be parked in the direction of permitted travel and with both wheels within twelve (12) inches of the curb or edge of the roadway.
- (i) On the roadway side of any vehicle stopped or parked at the edge or curb of a street in such a manner as to constitute double line or multiple line parking.
- (j) Upon any street or highway within ten (10) feet of a fire hydrant.

- (k) Upon or in front of any private road or driveway without consent of the owner of said private road or driveway.
- (I) Upon any street or highway, within twenty (20) feet of an intersecting way, except alleys.
- (m) On bridges or approaches thereto.
- (n) Upon any street or highway where the parking will obstruct or hide from view any traffic control signal or detector.
- (o) Upon or within the limits of any street or highway for a period of time exceeding twenty-four (24) consecutive hours without the permission of the police department whether or not such vehicle is disabled and preparations are being made by the owner of operator for its removal.
- (p) Within a bicycle lane.
- (g) Within a fire lane.
- (r) Within a handicap zone without proper authority.
- (s) Within a tow zone.
- (t) Alongside or opposite any street excavation or obstruction when such stopping, standing, or parking would obstruct traffic.
- (u) Within fifteen (15) feet of the wall of a fire station or directly across the street from such fire station provided signs are erected acquainting the driver of such restriction.

Section 2. Parking Locations and Prohibitions

Parking is prohibited, restricted, or limited as to time, space, and streets in accordance with Schedule #1 hereto appended. No operator shall park a vehicle in a designated prohibited location or in a restricted location for a period longer than is designated in Schedule #1.

Section 3. Parking within Designated Spaces

Each vehicle shall be entirely within the painted lines designated for its individual use.

Section 4. No On-Street Parking During Snow Removal Operations

No person shall allow, permit, or suffer any vehicle registered in his or her name, other than one acting in an emergency, to be parked on any street or any municipal off-street parking area while snow removal operations are underway.

Section 5. Parking Vehicles for Sale Prohibited

It shall be unlawful for any person to park upon a street, highway or off-street parking area controlled by the town any vehicle displayed for sale.

Section 6. Repairing of Vehicles

No person shall repair, wash or clean vehicles or other conveyances or cause them to be repaired, washed, or cleaned in or upon any public way or municipal parking area, nor shall any person occupy any part of a public way or off-street parking area controlled by the town as storage for any vehicle. In the event of an emergency, temporary repairs may be made.

Section 7. Parking Prohibited at Safety Zones

No person shall park a vehicle within twenty (20) feet of either end of a safety zone which is located within thirty (30) feet of the curb or edge of the roadway.

Section 8. Parking Vehicles for the Primary Purpose of Hawking and Peddling is Prohibited

It shall be unlawful for any person to stop, stand or park any vehicle on any public way within the town for the purpose of using such a vehicle as a stand for displaying articles for sale, or for vending, hawking or peddling.

ARTICLE V: ADVERTISING, SIGNS, PARADES

Section 1. Using Vehicle for Sole Purpose of Displaying Advertising Prohibited

No person shall operate or park a vehicle on any street or highway for the purpose of displaying advertising signs.

Section 2. Parades and Processions

No procession or parade except a funeral as provided by these Rules and Regulations shall occupy, march, or proceed along any street or highway except in accordance with a permit issued by the Select Board or the Town Manager as their designee, and such other regulations as are set forth herein which may apply.

ARTICLE VI: ONE-WAY TRAFFIC

Section 1. One-Way Traffic

The streets, portions thereof, or municipal off-street parking areas or parts thereof designated in Schedule #3 hereto appended and specifically incorporated in this section are declared to be one-way streets and all vehicles shall move on these streets or municipal off-street parking areas or parts thereof in the direction so designated.

ARTICLE VII: OPERATION OF VEHICLES

Section 1. Passing Vehicle Traveling in Same Direction

Except as herein otherwise provided, the driver of a vehicle passing another vehicle traveling in the same direction shall drive a safe distance to the left of such other vehicle; and, if the way is of sufficient width for the two vehicles to pass, the driver of the leading one shall not unnecessarily obstruct the other. Except when overtaking and passing on the right is permitted; the driver of an overtaken vehicle shall give way to the right in favor of the overtaking vehicle on visible signal and shall not increase the speed of his or her vehicle until completely passed by the overtaking vehicle. The driver of a vehicle may, if the roadway is free from obstruction and of sufficient width for two or more lines of moving vehicles, overtake and pass upon the right of another vehicle when the vehicle overtaken is (a) making or about to make a left turn or (b) upon a one-way street.

Section 2. Obstructing Traffic

No person shall drive in such a manner as to unnecessarily obstruct the normal movement of traffic upon any street or highway. Officers are hereby authorized to require any driver who fails to comply with this section to drive to the side of the roadway and wait until such traffic that has been delayed has passed.

The driver of a motor vehicle shall not cross or enter an intersection, unless it is able to proceed through without

stopping or blocking vehicles from traveling in the free direction. A green light is no defense to blocking an intersection. If necessary, the driver must wait for another cycle of the traffic signals in order to proceed.

Section 3. Following Too Closely

The driver of a vehicle shall not follow another vehicle closer than is reasonable and prudent, having due regard to the speed of such vehicle and the traffic upon and condition of the street or highway.

Section 4. Slow Vehicles to Stay 200 Feet Apart

Upon roadways less than twenty-seven feet wide and upon which vehicular traffic is permitted to operate in both directions, the driver of any slow-moving commercial vehicle when traveling outside of a business or residential district shall not follow another slow-moving commercial vehicle within two hundred (200) feet, but this shall not be construed to prevent such slow-moving commercial vehicle from overtaking and passing another slow-moving commercial vehicle. This section shall not apply to funerals or other lawful processions.

Section 5. Care in Starting, Stopping, Turning, and Braking

The driver of any vehicle before starting, stopping, turning from a direct line, or backing shall first see that such movement can be made safely. If such movement cannot be made safely or it interferes unduly with the normal movement of other traffic, said driver shall wait for a more favorable opportunity to make such a movement. If the operation of another vehicle should be affected by a stopping or turning movement, the driver of such other vehicle shall be given a plainly visible signal, as required by Chapter 90, Section 14B of the General Laws.

Section 6. Sound Horn When Necessary

The driver of a vehicle shall give an audible warning with a horn or other suitable warning device whenever necessary to ensure safe operation.

Section 7. Obedience to Traffic Control Signals

Color and arrow indications of traffic control signals shall have the commands described to them in this section and no other meanings and every driver of a vehicle shall comply therewith, except when otherwise directed by an officer or by a lawful traffic regulating sign (other than a "stop sign"), signal or device or as provided in Section 12 of this Article. In no case shall a driver enter or proceed through an intersection without due regard to the safety of other persons within the intersection regardless of what indications may be given by traffic control signals.

- (a) Green: While the green lens is illuminated, drivers facing the signal may proceed, but shall yield the right-of way to other vehicles, bicycles, and pedestrians within the intersection. The driver of a vehicle shall not cross or enter and intersection which it is unable to proceed through, without stopping and thereby blocking other vehicles from traveling in a free direction. A green light is no defense to blocking the intersection. The driver must wait for another cycle of the signal light, if necessary.
- (b) Green Arrows: When a green arrow is illuminated for a travel lane, drivers in that lane may make a turn in the direction of the arrow.
- (c) Yellow: While the yellow lens is illuminated, a driver shall stop if it is safe to do so. If a driver is already stopped at an intersection, they shall not proceed until the green light is illuminated.
- (d) Flashing Yellow: A flashing yellow lens shall indicate a warning. A driver shall slow and proceed with caution.

- (e) Red: While the red lens is illuminated, drivers facing the signal shall stop just prior to the stop line, provided however, that if a green arrow is illuminated at the same time, drivers may enter the intersection to make the movement permitted by such arrow. A driver may make a right turn on a red signal only after coming to a complete stop: then they shall obey the right-of-way laws and proceed when it is safe to do so. A driver may not make a turn on a red signal if there is a "NO TURN ON RED" sign posted.
- (f) Flashing Red: When a red lens or red arrow is illuminated in a traffic control signal by intermittent flashes, a driver must come to a complete stop, obey the right-of-way laws, and proceed when it is safe to do so. If a white stop line or cross walk is present; the driver must stop before the line. When there is no pavement markings, the driver must stop as close to the intersection as needed to view traffic in both directions before entering the intersection.
- (g) Traffic Lights Not Functioning: If signals are blacked out or not functioning, a driver shall treat the intersection as having Stop Signs in all directions and proceed when it is safe to do so.

Section 8. Keep to the Right of Roadway Division

Upon such roadways as are divided by a grass plot, or by any structure or area, drivers shall keep to the right of such a division except when otherwise directed by an officer, signs, signals, or markings.

Section 9. Driving on Streets under Construction or Repair

No operator shall enter upon any street or highway or section thereof, when, by reason of construction, maintenance or because of some unprotected hazard, the street is closed to travel, and one or more signs, lights or signals have been erected to indicate that all or part of the street or highway is not to be used, or when so advised by an officer or Department of Public Works employee.

The Director of Public Works may temporarily close any street or highway or section thereof for the purposes of repair, construction and maintenance of the street or highway or the utilities within it, or because of some unprotected hazard and shall cause to be erected one or more signs, lights, or signals to indicate that all or part of the road surface of the street or highway is not to be used. Officers or Department of Public Works employees may be used instead of, or to supplement, signs, lights, or signals.

Section 10. No Driving on Sidewalks

The driver of a vehicle shall not drive upon any sidewalk except at a driveway.

Section 11. Funerals to be Properly Identified

A funeral composed entirely or partly of a procession of vehicles shall be identified as such by means of pennants bearing a purple symbol attached to all vehicles or every driver in the procession shall turn on the headlights of said vehicle.

Section 12. Rights and Duties of Drivers in Funeral or Other Processions

It shall be the duty of each driver in a funeral or other procession to keep as near to the right edge of the roadway as is feasible and to follow the vehicle ahead as closely as is practical and safe.

At an intersection where a traffic control signal is operating, the driver of the first vehicle in a funeral or other procession shall be the only one required to stop for a red or yellow indication.

At an intersection where a lawful stop or yield sign exists, the driver of the first vehicle in a funeral or other procession shall be the only one required to stop before proceeding through the intersection.

Section 13. Emerging from Alley or Private Driveway

The operator of a vehicle emerging from a private road, driveway or garage shall stop such vehicle immediately prior to driving upon the sidewalk area extending across such driveway or garage, and where no such sidewalk exists the stop shall be made at the building or property line as the case may be and upon entering the roadway shall yield the right of way to all vehicles and pedestrians approaching on the roadway or sidewalk.

Section 14. Driving or Parking on Channelized Island

No person shall drive over or park a motor vehicle upon any channelizing island as defined in these Rules and Regulations, unless directed to do so by a police officer.

Section 15. U-Turns Prohibited

No operator shall back or turn a vehicle so as to proceed in the direction opposite to that in which the vehicle is headed or traveling on the streets or parts of streets designated in Schedule #3 of these Rules and Regulations.

Section 16. Prohibited and Mandatory Turns

The streets or portions thereof designated in Number 3 hereto appended and specifically incorporated in this section are declared to have prohibited turns and all vehicular traffic shall move on those streets or portions thereof in the direction designated in said Schedule Number 3.

Section 17. Workers and Equipment in the Street

Whenever traffic signs or construction barricades are erected, or warning lights are displayed in or adjacent to a street to notify of the presence of workers and equipment, in such street every motorist shall regulate the speed of his vehicle in a manner and to a degree consistent with the particular condition.

Section 18. Obedience to Isolated Stop Signs

Except when directed to proceed by a police officer, every driver of a vehicle approaching a stop sign or a flashing red signal indication shall stop at a clearly marked stop line, but if none, before entering the crosswalk on the near side of the intersection, or, if none, then at the point nearest the intersecting roadway where the driver has a view of approaching traffic on the intersecting roadway before entering it. After having stopped, the driver shall yield the right of way to any vehicle in the intersection or approaching on another roadway so closely as to constitute an immediate hazard during the time when such driver is moving across or within the intersection or junction of roadways. In accordance with the foregoing, the erection and maintenance of official Stop Signs or flashing red signal indications are authorized so as to face the streets or intersections as provided in Schedule No. 5 of these Rules and Regulations.

Section 19. Obedience to Yield Signs

The driver of a vehicle approaching a yield sign shall slow down to a speed reasonable for the existing conditions and, if required for safety to stop, shall stop at a clearly marked stop line, but if none, before entering the crosswalk on the near side of the intersection, or, if none, then at the point nearest the intersecting roadway where the driver has a view of approaching traffic on the intersecting roadway before entering it. After slowing or stopping, the driver shall yield the right of way to any vehicle in the intersection or approaching on another roadway so closely as to constitute an

immediate hazard during the time such driver is moving across or within the intersection or junction of roadways; provided, however, that if such a driver is involved in a collision with a vehicle in the intersection or junction of roadways, after driving past a yield sign without stopping, such collision shall be deemed prima facie evidence of his failure to yield the right of way.

In accordance with the foregoing, the erection and maintenance of official Yield Signs is authorized so as to face the streets or intersections as provided for in Schedule #5 of these Rules and Regulations.

Section 20. Clinging to Motor Vehicles

It shall be unlawful for any person traveling upon a bicycle, motorcycle, coaster, sled, roller skates, or any toy vehicle to cling to, or attach himself or his vehicle to any moving vehicle or streetcar upon any roadway.

Section 21. Driving Through Safety Zones Prohibited

It shall be unlawful for the driver of a vehicle, except on signal from a police officer, to drive the same over or through a safety zone.

Section 22. Unlawful Riding

It shall be unlawful for any reason to ride on any portion of a vehicle not designated or intended for the use of passengers when the vehicle is in motion. This provision shall not apply to any employee engaged in the necessary discharge of a duty or within truck bodies in space intended for merchandise.

Section 23. Operation of Heavy Commercial Vehicles

- (a) The use and operation of heavy commercial vehicles having a carrying capacity of more than 2½ tons, are hereby restricted from the streets or portions thereof designated in Schedule No. 4 hereto appended and specifically incorporated in this section are declared to be heavy commercial vehicle exclusions.
- (b) Exemptions Part 1 of this Section shall not apply to heavy commercial vehicles going to or coming from places upon said streets for the purpose of making deliveries of goods, materials, or merchandise to or similar collections form abutting land or buildings or adjoining streets or ways to which access cannot otherwise be gained; or to vehicles used in connection with the construction, maintenance and repair of said streets or public utilities therein; or to Federal, State, Municipal or public service corporation owned vehicles.

Section 24 Bridge Weight Limits

All vehicles shall comply with the weight limits designated in Schedule 4 hereto appended and specifically incorporated in this section.

Section 25. Speed Limits on Unposted Roadways

The speed limit on any roadway within a thickly settled or business district shall be no more than 30 mph. At no time shall any person operating a motor vehicle in such a district run it at a rate of speed greater than is reasonable and proper having regard to traffic and the use of the way and the safety of the public.

ARTICLE VIII: PEDESTRIAN CONTROL REGULATIONS (Reserved for Future Use)

ARTICLE IX: TOW AWAY ZONE REGULATIONS (Reserved for Future Use)

ARTICLE X: ZONE OF QUIET

The Chief of Police may temporarily establish a zone of quiet upon any street where a person is seriously ill. Said temporary zone of quiet shall embrace all territory within a radius of two hundred (200) feet of the building occupied by the sick person. Said temporary zones of quiet shall be designated by the Chief of Police by causing to be placed at a conspicuous place in the street a sign or marker bearing the words ZONE OF QUIET.

ARTICLE XI: GENERAL PROVISIONS AND PENALTIES

Section 1. Drivers Must Report Accidents

The driver of any vehicle involved in an accident resulting in the injury or death of any person, or property damage to an apparent total extent of one thousand dollars (\$1,000) to any one vehicle or other property shall report such accidents to police within five (5) days, as required by Chapter 90, Section 26 of the General Laws.

Section 2. Owner Prima Facie Responsibilities for Violators

If any vehicle is found upon any street or highway in violation of any provisions of these Rules and Regulations and the Identity of the driver cannot be determined, the owner or the person in whose name such vehicle is registered or last known registered owner if not presently registered, shall be held prima facie responsible for such violation.

Section 3. Penalties

Except as otherwise provided, any person convicted of a violation of these Rules and Regulations shall be punished by a fine of not more than fifteen dollars (\$15.00), if paid within twenty-one days; twenty dollars (\$20.00), if paid thereafter but before the parking clerk reports to the registrar as provided under Chapter 90, Section 20A½, and thirty-five dollars (\$35.00), if paid thereafter.

Any person violating any provision of any rule, regulation or order regulating parking of motor vehicles within the Town of Medway, made by any official body authorized to make the same, will be dealt with as provided by Chapter 90 Section 20C of the Massachusetts General Laws, as amended, and any person violating any of the rules and regulations applicable to state highways, made by the Massachusetts Department of Transportation under authority of Chapter 85 Section 2 of the General Laws, as amended, shall be subject to the penalty provided in said rules and regulations. Parking fines are noted in Schedule #7.

Section 4. Repeal of Rules Previously Adopted

All rules previously adopted by the Select Board for the purpose of governing or restricting traffic are hereby repealed and all other rules or regulations or parts thereof in conflict with or inconsistent with any provisions of these Rules and Regulations are hereby repealed, except that this repeal shall not affect or prevent the prosecution or punishment of any person for any act done or committed in violation of any rules or regulations hereby repealed, prior to the taking effect of these Rules and Regulations.

Section 5. Effect of Regulations

All existing rules and regulations governing the operation of vehicles or the use of ways by pedestrians, which are inconsistent herewith, are hereby expressly repealed. This repeal shall not, however, affect any punishment or penalty imposed or any complaint or prosecution pending at the time of passage hereof for any offense committed under any of the said rules and regulations hereby repealed. If any section, sub-section, sentence, clause, or phrase of these Rules and Regulations is for any reason unconstitutional, such decision shall not affect the validity of the remaining portion of these Rules and Regulations.

BYLAW XI FIRE LANES

Town of Medway By-law Article XI Fire Lanes

- **11. 1 (a)** For the protection of persons and property from the hazards of fire within a shopping mall or shopping center and to facilitate the operation of fire-fighting apparatus therein, on order of the chief of the Fire Department there shall be established fire lanes designated as such by posting and marking the Emits of such lanes by hatch marks. The fire lanes shall be fourteen (14) feet in width extending outward from the sidewalk curb.
- **11.2 (a)** It shall be unlawful to obstruct any fire lane or park a vehicle therein or leave a vehicle therein unattended except commercial vehicles making deliveries to any stores bound by said fire lanes.
- **11.3 (a)** Any vehicle parked in violation of Section 11.2 may be removed or towed at the expense of the owner on order of a member of the Police Department without liability to the town or its officers, agents or employees.
- **11.4 (a)** The owner or manager of the shopping mall shall provide and install all sign, posting and markings of fire lanes as designated by the Fire Chief.
- **11.5 (a)** Any person convicted of violating any of the above provisions shall be punished by a fine of five dollars (\$5.00) for the first offense, ten dollars (\$10.00) for the second offense, and twenty-five dollars (\$25.00) for each subsequent offense committed during any twelve-month period.

BYLAW XII SECTION 17 SNOW AND ICE DISPOSAL BYLAW

No person shall place snow from a plow, shovel, snow blower, or by any other means on the traveled portion of any roadway. Whoever shall violate this bylaw shall pay a fine as specified in Section 12.15 of this Bylaw.

BYLAW XII SECTION 26 REGULATION OF PARKING AND STORAGE **OF COMMERCIAL VEHICLES**

Regulation of Parking and Storage of Commercial Vehicles

(a) Purpose - The purpose of this By-law is to regulate the on-street parking of certain commercial vehicles and the outdoor parking/storage of certain commercial vehicles. This By-law is adopted to promote safe vehicular traffic, to preserve peace and good order, to protect the character of residential neighborhoods, to promote the aesthetic beauty of the community and hence the value of the property located therein, and to promote the health, safety, and general welfare of the citizens of the Town of Medway.

(b) Definitions

- (1) Commercial Vehicle Any vehicle defined as such by the Massachusetts Registry of Motor Vehicles in 540 CMR 2.05
- (2) Gross Vehicle Weight Rating (GVWR) The value specified by the manufacturer as the loaded weight of a single vehicle including the vehicle's chassis, body, engine, engine fluids, fuel, accessories, driver, passengers, and cargo but excluding that of any trailers, as established by the National Highway Traffic Safety Administration, U.S. Department of Transportation.

(c) Prohibitions/Limitations

- (1) No person shall allow, permit, or cause a commercial motor vehicle having a Class 4 gross vehicle weight rating or higher to be parked at any location on any public or private way within the Town of Medway for any period in excess of six hours in any twenty-four hour period, unless said vehicle is in the process of being used for loading, unloading, or providing a service to one or more adjacent properties including but not limited to landscaping, construction, driveway paving etc.
- (2) No commercial vehicle with a class 5 gross vehicle weight rating or higher shall be parked within the standard front, side and rear setback areas as set forth in section 6.1 of the Zoning By-law for the zoning district where the property is located except that such vehicle maybe parked in the property's paved driveway where located with in the set back areas.

Whoever shall violate this bylaw shall pay a fine as specified in Section 12.15 of this Bylaw.
